

### CORALIE MALLON GRAY 1928-2007

or over 40 years, Coralie Gray served Wilbraham Academy and then Wilbraham & Monson Academy faithfully and well. Among her many professional roles were history teacher, Director of Library Services, and in later years, Academy archivist. She was friend and confidant to countless students. She was also an alumni parent; her son Steve '70W is a current member of the WMA faculty who coaches water polo and track & field, where he specializes in the field events.

When the Academy began to prepare for its Bicentennial anniversary, celebrated in 2004, Corky was an invaluable resource. She contributed her knowledge as well as Academy archival artifacts to the creation of the Bicentennial book, *Visions that Endure*, truly a labor of love.

At the time of the merger of Wilbraham and Monson Academies, it was Corky who combined elements of the crests of the two schools to create the formal WMA seal still used today. In 1979, Coralie was the moving force behind the addition of the Academy Historic District to the National Register of Historic Places. The district consists of thirty buildings, twenty-four of which belong to Wilbraham & Monson Academy.

In addition to her work at the Academy, Corky was a loyal citizen of Wilbraham, serving on the Wilbraham Public Library Board of Trustees, the Open Space Committee, the Historic District Survey Committee, the Town Records Advisory Committee, and the Athenaeum Society of Wilbraham. She was a proud member of the

Daughters of the American Revolution. She was a member Quota Club International of Springfield and the Society of American Archivists. She was a lecturer of histories for the Town of Wilbraham and for Wilbraham & Monson Academy. She was on the Board of Directors for both the American Red Cross and the Wilbraham Counseling Center. Her activities encompassed the Wilbraham Historical Commission, the MacDuffie School Alumni Board, and the Vestry at the Church of the Epiphany.

We will miss Corky; she was, in a very real sense, the institutional memory of Wilbraham & Monson Academy. At the memorial service held in Alumni Memorial Chapel in January, representatives from the town government, the Wilbraham Library, Quota International, and Wilbraham & Monson Academy spoke of her hard work and devotion to their organizations. Afterward, Cindy St. George Martowski '78 said, "I never realized all the wonderful things she did. I was a kid, and I just knew she was a fun person to be around."

## ROBERT TURNBULL HALE '55W 1938-2008

Bob Hale was a highly respected family man, entrepreneur, business leader, and philanthropist. In his retirement, he and Judy, who had been married for 46 years, summered in Westport Harbor, Massachusetts, and wintered in Naples, Florida. Bob died Friday, February 29, 2008, in Naples.

Bob was a member of the Wilbraham Academy Class of 1955. While at the Academy, he ran track and was on the tennis team for three years. He was the Editor in Chief of *Del Todo*, the Wilbraham yearbook, his senior year, having served as Junior Editor the year before. He was also a contributor to *Atlas*, a member of the debating club, and a member of Gold Key, serving as president his senior year. He shared many of these interests with his roommate, Peter Lincoln. Bob was also a campus leader at Tufts University, from which he graduated in 1959. He served in the Indianapolis National Guard from 1962 to 1965.

Bob's career in business was filled with entrepreneurial success. At the age of 28, he acquired and operated Hampshire Bookshop in Northampton, Massachusetts. After selling the bookshop, he founded Hampshire Imports, the exclusive importer of Laura Ashley to the United States, as well as Hampshire Marketing Systems, a successful paperwares business, which he also operated for years until its successful sale.

Bob and his son Rob then founded Network Plus, a national telecom firm, for which he served as Chairman of the Board and oversaw a successful IPO of the business.

The last company he founded, again with his son, is Granite Telecommunications, which is headquartered in Quincy and has been recognized as one of the fastest growing companies in the United States, currently employing over 600 people, 550 of whom reside in Massachusetts. Bob remained Granite's Chairman of the Board up until the time of his death



Bob supported numerous philanthropic causes. He and Judy funded the Hale Learning Center at Thayer Academy in Braintree, Massachusetts. They also started the Hale Pancreatic Research Foundation at Dana Farber Cancer Institute in Boston. Bob was an avid supporter of the Massachusetts Soldier Legacy Fund, Wilbraham Academy, Tufts University, Wellesley College, and the Westport Land Trust.

Bob enjoyed playing tennis and golf and the time it allowed him to spend with his buddies. He befriended everyone he met and treasured every friendship dearly.


